8 **ENACTMENT**

9 TO ESTABLISH THE JOINT COMMITTEE ON INAUGURAL
10 EVENTS

12 **Subtitle**

13 TO ESTABLISH THE JOINT COMMITTEE ON
14 INAUGURAL EVENTS; *BE IT ENACTED BY THE SENATE*
15 *AND STUDENTS ACTIVITIES BOARD OF THE UNIVERSITY*
16 *OF ARKANSAS AT MONTICELLO STUDENTS*
17 *GOVERNMENT ASSOCIATION*
18

19 **SECTION 1. SHORT TITLE.**

20
21 This Enactment may be cited as the “Inauguration Committee Act.”
22

23 **SEC. 2. ESTABLISHMENT.**

24
25 There is established an AD HOC joint committee with the Student
26 Activities Board (SAB) to be known as the “The Joint Committee on
27 Inaugural Events” (in this Enactment referred to as the “Committee”).
28

29 **SEC. 3. DUTIES OF COMMITTEE.**

30
31 The Committee shall:

32
33 *i.* plan, develop, and carry out such activities as the Committee
34 considers fitting and proper to commemorate the execution of
35 offices of the several officials of the Student Government
36 Association newly elected in the Spring 2009 general election;

38 *ii.* to work with the Director of Student Programs and Activities,
39 Vice-Chancellor of Student Affairs, and other University officials in
40 the coordination of planning and carrying out activities to

1 commemorate the execution of offices of the several officials of the
2 Student Government Association newly elected in the Spring 2009
3 general election;

5 *iii.* to submit to the Senate and President reports.
6

7 **SEC. 4. MEMBERSHIP.**
8

9 (a) The Committee shall be composed of ten (10) members as follows:

10
11 *i.* Five (5) Senators appointed by the Senate President Pro-tempore.
12

13 *ii.* Five (5) SAB members appointed by the SAB Chairperson.
14

15 (b) Each member shall be appointed for the life of the Committee.
16

17 (c) All members of the Committee shall be appointed not later than five
18 (5) days after the date of the enactment of this Act.
19

20 (d) A vacancy on the Committee shall:

21
22 *i.* not affect the powers of the Committee; and
23

24 *ii.* be filled in the manner in which the original appointment was
25 made.
26

27 (e) A majority of the members of the Committee shall constitute a quorum
28 but a lesser number may hold hearings.
29

30 (f) The chairperson of the Committee shall be elected by a majority vote of
31 the members of the Committee.
32

33 **SEC. 5. POWERS OF COMMITTEE.**
34

35 (a) The Committee may, for the purpose of carrying out this Act, hold
36 hearings, sit and act at times and places, take testimony, and receive
37 evidence as the Committee considers appropriate.
38

39 (b) The Committee may secure directly from any department or agency of
40 the Student Government Association information necessary to enable it to

1 carry out its duties under this Act. Upon request of the chairperson of the
2 Committee, the head of that department or agency shall furnish that
3 information to the Committee.
4

5 (c) The Committee may solicit, accept, use, and dispose of gifts, bequests,
6 or devises of money, services, or property, both real and personal, for the
7 purpose of aiding or facilitating its work.
8

9 **SEC. 7. REPORTS.**

10
11 (a) The Committee shall submit to the President and the Senate monthly
12 reports on the progress and revenue and expenditures of the Committee,
13 including a list of each gift, bequest, or devise to the Committee, together
14 with the identity of the donor of each gift, bequest, or devise.
15

16 (b) The Committee may submit to the President and Congress interim
17 reports as the Committee considers appropriate.
18

19 (c) Not later than April 17, 2009, the Committee shall submit a final report
20 to the President and the Congress containing:

- 21 *i.* a summary of the activities of the Committee;
- 22
- 23 *ii.* a final accounting of funds received and expended by the
24 Committee; and
- 25
- 26 *iii.* the findings, conclusions, and final recommendations of the
27 Committee.
28

29
30 **SEC. 8. TERMINATION.**

31
32 The Committee may terminate on such date as the Committee may
33 determine after it submits its final report pursuant to section 7(c), but not
34 later than April 29, 2009; or upon completion of the Committee's
35 objectives, as laid out in section 3.
